Amount varies and depends on the number of scholarships awarded. **Selection criteria:** Academic standing, extra-curricular involvement, and financial need.
- The Jeanne S. Berger Scholarship:** Amount depends on the number of scholarships awarded. **Selection criteria:** Applicant must be a female, age 25 or older, custodial parent of at least one minor child, a 2.5 average cumulative GPA (or better), and demonstrate financial need.
- The Beverly Rubens Gordon Scholarship:** The scholarship is awarded to two part-time day students. **Selection criteria:** Academic standing and financial need.
- The David Holtz Memorial Scholarship:** Amount depends on the number of scholarships awarded. **Selection criteria:** Academic standing with an emphasis on the applicant's Contracts grade and financial need.
- The Cindy Raisch Memorial Scholarship:** The late Ms. Raisch was a former Associate Dean and a former legal writing instructor at Whittier Law School. Amount varies and depends on the number of scholarships awarded. **Selection criteria:** Academic achievement and financial need.
